TODAY, THEY GOT INTO A VERBAL ARGUMENT AND ROBYN WAS GOING TO LEAVE BUT SHE CAME BACK IN THE HOME YELLING ABOUT HER WEDDING RING. REFUSED TO GIVE IT TO HER. WAS ON THE COUCH IN THE FAMILY ROOM WHEN ROBYN APPROACHED AND THEN SWUNG HER ARM AND HIT HIM IN THE SIDE OF THE HEAD, AND SHE SWUNG MULTIPLE MORE TIMES BUT HE BLOCKED WITH HIS FOREARM. ROBYN BEGAN TO LEAVE AND FOLLOWED HER TO THE DOOR. WHEN THEY GOT TO THE DOOR, ROBYN FOLLOWED BACK INSIDE THE HOUSE AND STARTED YELLING AT HIM, SHE THEN STRUCK HIM MULTIPLE MORE TIMES IN THE HEAD AND FACE AREA WHILE BACKED UP AND ATTEMPTED TO BLOCK HER. THEN PULLED HER BY THE HAIR TO THE GROUND AND MOUNTED HER IN AN ATTEMPT TO GET HER TO CALM DOWN. THE CHILDREN THEN RAN OVER UPSET. LET ROBYN UP AND SHE LEFT THE RESIDENCE. SHOWED ME VIDEO FOOTAGE WHICH CONFIRMED THE EVENTS THAT HAPPENED BY THE FRONT DOOR (NOT THE COUCH) . HAD A SMALL RED MARK ON THE RIGHT SIDE OF HIS FACE, CORROBORATING THAT HE WAS HIT IN THE FACE. I THEN SPOKE WITH BOTH CHILDREN SEPARATELY AND THEY BOTH STORY, HOWEVER, KATHRYN DID NOT SEE THE INCIDENT ON THE COUCH.
