On 07/25/2022 at approximately 10:55pm Trooper Perez (in training) and I, Trooper Masterson were dispatched to a traffic stop southbound on Interstate 95 (State road 9) to State Road 806 (Atlantic Ave). We arrived on scene and observed a blue Toyota Camry bearing license plate "DIUM19". We observed a white male wearing a red shirt and green shorts in front of the blue Camry. The male was later identified as RYAN DOUGLAS SMEDBERG (S-531-724-89-461-0) who is also the registered owner of the vehicle.

We spoke with Sergeant Torres. Sgt Torres conducted a traffic stop on the blue Toyota speed (105mph in a posted 65mph zone). Sgt Torres stated the driver of the vehicle did not initially notice the emergency lights and siren directly behind his vehicle as he attempted to pull him over. The vehicle did not pull over until a mile south from where it was originally stopped. Sgt Torres stated he observed the driver to have red and glossy eyes as well as slurred speech causing him to believe the driver was under the influence of alcoholic beverage and had the driver step out of the vehicle. Sgt Torres identified the driver by his Florida driver license. Sgt Torres asked Mr. Smedberg if he had consumed any alcoholic beverages. Mr. Smedberg stated yes, he had been drinking whiskey.

As we spoke with Mr. Smedberg, we noticed odd behavior. Mr. Smedberg spoke with a slow cadence and moved in a lethargic manner. Mr. Smedberg drug his feet and moved with his head low. Mr. Smedberg eyes were red and glossy. Mr. Smedberg pupils were dilated. Mr. Smedberg seemed care free and asked no questions and was unconcerned. After observing Mr. Smedberg impairment of normal faculties, we asked him if he would like to perform voluntary standardized field sobriety exercises. He stated yes. We asked Mr. Smedberg if he suffers from diabetes, seizures, strokes or any medical problems. He stated no.

The first exercise was the Horizontal Gaze Nystagmus. Mr. Smedberg was placed in the starting position of standing up straight with feet together and arms by his side. I instructed Mr. Smedberg to keep his head and body still during the entirety of the first exercise. I explained to Mr. Smedberg that I would move my pen from side to side and for him to move his eyes only. I asked Mr. Smedberg if

he understood the instructions Mr. Smedberg stated that he understood. Mr. Smedberg had a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and onset of Nystagmus prior to 45 degrees in both eyes. Vertical Gaze Nystagmus was tested. Vertical Gaze Nystagmus was not present. Mr. Smedberg swayed heavily in an orbital manner.

The second exercise was the Walk and Turn. I instructed and demonstrated Mr. Smedberg to place his left foot on the line followed by his right foot in front of his left foot touching heel to toe. I explained and demonstrated to Mr. Smedberg that his arms are to stay by his side and not to raise at any point during this exercise. I instructed and demonstrated Mr. Smedberg to stay in that position (the starting position) while I give the rest of the instruction to the test. I specifically instructed Mr. Smedberg to not begin the exercise until told to do so. I explained and demonstrated to Mr. Smedberg, when I tell him to begin that his first step will be with his left foot. I instructed and demonstrated to Mr. Smedberg that he will take nine heels to toe steps and to count out loud what number step he was on while looking at his step. I instructed and demonstrated the turn portion of the exercise that comes after the ninth step. I explained to Mr. Smedberg the turn will consist of him keeping his lead foot on the ground and pivoting off it with a series of small steps using his other foot. I asked Mr. Smedberg if he understood the instructions throughout giving the instructions. Mr. Smedberg stated he did understand the instructions. Mr. Smedberg missed heel to toe several times. Mr. Smedberg stepped off the line. Mr. Smedberg took ten steps on the second set of 9 steps. Mr. Smedberg stopped and paused during the exercise.

The third exercise was the One Leg Stand. I instructed and demonstrated Mr. Smedberg to stand with feet together and arms by his side; the same as the first exercise. I specifically informed Mr. Smedberg to not begin the exercise until told to do so. I explained and demonstrated to Mr. Smedberg that he will pick up any leg of choice and raise it above the ground approximately six inches and to look at his foot until told to place his foot back on the ground. I instructed Mr. Smedberg to count out loud the seconds that pass by while his foot is raised above the ground. I informed Mr. Smedberg to not place his foot on the ground unless he felt they were
