The defendant was operating a red 2020 Dodge Challenger, 2 door, Florida tag QLBI95. The defendant drove at a speed of 65 MPH in a properly posted 40 MPH speed limit, which was visually estimated and patrol car paced (TPD DUI unit 5055). A traffic stop was conducted for unlawful speed. The defendant had a strong and distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed. The defendant initially tried to avoid talking or looking in my direction. The defendant displayed cognitive issues as it related to requested documents and recalling information that had already been relayed to her as she asked the same questions repeatedly. The defendant denied alcohol consumption, and when asked about the odor she alluded to someone having been in the car earlier who had consumed alcohol. The defendant was mildly unsteady exiting the vehicle, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after she was advised of the Implied Consent Warnings. The defendant was positively identified by her Florida DL.
