The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2016 Landrover SUV (FL Tag #14BUZP) eastbound on Kennedy Blvd W, when he slammed on his brakes and slid to a stop behind another white Landrover SUV, that was stopped at the Howard Av N red light. Once the light turned green, both vehicles turned left (northbound) onto Howard Av N, and I followed behind. While following the defendant, I observed him to drive down the center of 2 lanes, straddling the broken lane divider line, and weaving back and forth. During the traffic stop for the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, poor coordination, poor balance, slow/deliberate movements, tired/lethargic appearance, fumbling fingers, confusion with his paperwork, he admitted to drinking several Corona beers while at the Acropolis, and emitted a distinct odor of an alcoholic beverage from his breath. The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking. While at CBT, he was read Implied Consent and willingly provided 2 valid breath samples, measuring .240/.238 BrAC.
