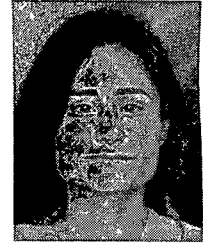

Before me this date personally appeared GUERRA, ALVARO (6314) who being first duly sworn deposes and says that on 22 day of December (year) 2021 at 100 NE 10TH AVENUE, HALLANDALE BEACH, FL 33009 (cnme location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

(BEARING FL TAG DFLK87) WHO WAS TRAVELING THE SAME DIRECTION THE VICTIM ADVISED HE OBSERVED THE DEFENDANT IN CONTROL OF THE STEERING WHEEL THE DEFENDANT VEHICLE'S RIGHT SIDE MADE CONTACT WITH VICTIM'S LEFT SIDE OF VEHICLE CAUSING APPROXIMATELY \$5,500 00 U S DOLLAR CURRENCY IN DAMAGES BETWEEN BOTH VEHICLES

AS I APPROACHED THE DEFENDANT, I NOTICED THAT IT WAS DIFFICULT FOR HER TO MAINTAIN HER BALANCE I THEN SMELLED A STRONG ODOR CONSISTENT TO THAT OF AN ALCOHOLIC BEVERAGE EMANATING FROM HER BREATH AND PERSON THE DEFENDANT HAD BLOODSHOT EYES AND SPONTANEOUSLY ADVISED SHE HAD A COUPLE OF DRINKS I ADVISED THE DEFENDANT I WAS CONDUCTING A DUI INVESTIGATION I THEN ASKED HER TO TAKE OFF HER ANKLE WEDGES WITH FLAT BOTTOMS IN CASE IT PREVENTED HER FROM DOING THE ROADSIDE SOBRIETY EXERCISES

THE DEFENDANT WAS TAKEN TO A SECURE, FLAT, DRY, WELL-LIT AREA, AT THE 100 BLOCK OF NE 10TH AVENUE I THEN TOLD THE DEFENDANT TO PERFORM A SERIES OF EXERCISES THE EXERCISES CONSISTED OF THE FOLLOWING

1 HGN (FAILED INDICATORS)- I OBSERVED THE DEFENDANT MOVING HER HEAD FROM LEFT TO RIGHT WHEN FOLLOWING THE STIMULUS (PEN), EVEN THOUGH SHE WAS TOLD NOT TO MOVE HER HEAD I OBSERVED THE DEFENDANT TO HAVE LACK OF SMOOTH PURSUIT IN BOTH EYES, OBSERVED A DISTINCT SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION IN BOTH EYES, AND OBSERVED JERKING OF HER EYES WHEN DOING THE VERTICAL GAZE

2 WALK AND TURN (FAILED INDICATORS)- THE DEFENDANT WAS UNABLE TO KEEP BALANCE WHILE LISTENING TO INSTRUCTIONS AND STUMBLED WHILE WALKING THE DEFENDANT ALSO STEPPED OFF LINE MULTIPLE TIMES, MISSING STEPS 1,2,3,4,5,6,7,8,9,10 AND COUNTED UNTIL 11 THE

Before me this date personally appeared GUERRA, ALVARO (6314) who being first duly sworn deposes and says that on 22 day of December, (year) 2021 at 100 NE 10TH AVENUE, HALLANDALE BEACH, FL 33009 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

DEFENDANT FAILED TO PIVOT AS INSTRUCTED AND WHILE COMING BACK, SHE MISSED STEP 1, 2, 3, 4, 5, 6, 7, 8, 9, 10

3 ONE-LEG STAND TEST (FAILED INDICATORS)- THE DEFENDANT SWAYED WHILE BALANCING, USED ARMS TO BALANCE, AND COULD NOT COMPLETE THE TEST DUE TO CONTINUOUSLY PUTTING HER FOOT DOWN THE DEFENDANT WAS GIVEN A SECOND CHANCE AND FAILED AS WELL
