On the above date the listed defendant was driving a 2019 Toyt 4 door vehicle, Virginia tag UWY2378, within the city limits of Tampa. Deputy Sergeant E. Remia was working off duty when he saw the defendant driving his vehicle the wrong direction on Florida Ave. The defendant was traveling south bound on a one way street north bound.
