Probable Cause Affidavit

Before me this date personally appeared PAEZ, JORGE (874) who being first duly sworn deposes and says that on 26 day of May (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
15040 N. Saxon Circle.

Victim #1 stated her uncle, Defendant- Sami Ibrahim Mahmoud, punched her in the face numerous times which led to the bleeding in her face. She believes her nose was broken. Victim #1 stated she initially heard an argument between the defendant who was yelling at her mother and sister [REDACTED] which was taking place inside one of the bedrooms. Upon entering the bedroom, she observed the defendant striking her mother [REDACTED] and her teenaged sister [REDACTED] with a closed fist. Victim #1 then grabbed a bat and struck the defendant in order to defend her mother and sister. Victim #1 stated the defendant then turned around and punched Victim #1 several times on her face with a closed fist. She was eventually able to get away from the defendant and exited the residence and waited for Police arrival.

Detective Hobales arrived soon after and we both made contact with the defendant, Sami Ibrahim Mahmoud, inside the residence. Sami was agitated and I advised him to relax and take a seat on his couch in which he complied. Sami pointed to the right side of his head and spontaneously stated victim #1 struck him with a bat to the side of his head. He then stated he was involved in a verbal dispute with his sister [REDACTED] which escalated but doesn't recall what occurred afterward. The defendant then complained of being dizzy and Davie Fire Rescue transported him to Memorial Regional in Hollywood for a medical evaluation and was accompanied by Officer E. Stuehrenberg and Officer Broder.

I then spoke with [REDACTED] who is a juvenile. Victim #2 stated she overheard an argument taking place between the defendant and his wife, [REDACTED],

Before me this date personally appeared PAEZ, JORGE (874) who being first duly sworn deposes and says that on 26 day of May, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

taking place inside one of the bedrooms. Upon entering the room, she observed the defendant grabbing [REDACTED] neck and striking her several times with a closed fist throughout her chest and arm area. Victim #2 then attempted to intervene and the defendant pushed her to the ground and began stomping on her several times. Victim #2 then stated her mother [REDACTED] intervened along with her sister, Victim #1 but the defendant who is much larger, began punching both [REDACTED] and victim #1.

I then spoke with victim #3, [REDACTED], who stated she was only involved in a verbal dispute with the defendant, who is her husband. She denied being choked and/or being struck by the defendant. She was uncooperative and didn't want to provide me with any further details.

Victim #1 was transported to Cleveland Clinic for a medical evaluation. At this time, victim #1 doesn't appear to have sustained any permanent disfigurement. The defendant was arrested and charged with 3 counts of Domestic Simple Battery.
