Saxon Circle. Victim #1 stated her uncle, Defendant- Sami Ibrahim Mahmoud, punched her in the face numerous times which led to the bleeding in her face. She believes her nose was broken. Victim #1 stated she initially heard an argument between the defendant who was yelling at her mother and sister which was taking place inside one of the bedrooms. Upon entering the bedroom, she observed the defendant and her teenaged sister 🕮 striking her mother closed fist. Victim #1 then grabbed a bat and struck the defendant in order to defend her mother and sister. Victim #1 stated the defendant then turned around and punched Victim #1 several times on her face with a closed fist. She was eventually able to get away from the defendant and exited the residence and waited for Police arrival. Detective Hobales arrived soon after and we both made contact with the defendant, Sami Ibrahım Mahmoud, ınsıde the residence. Samı was agıtated and I advised him to relax and take a seat on his couch in which he complied. Sami pointed to the right side of his head and spontaneously stated victim #1 struck him with a bat to the side of his head. He then stated he was involved in a verbal dispute with his sister which escalated but doesn't recall what occurred afterward. The defendant then complained of being dizzy and Davie Fire Rescue transported him to Memorial Regional in Hollywood for a medical evaluation and was accompanied by Officer E. Stuehrenberg and Officer Broder. who is a juvenile.
