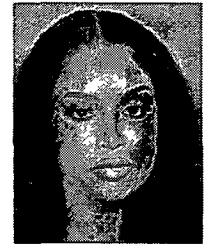

Before me this date personally appeared GUZMAN JOSE M (18795) who being first duly sworn deposes and says that on 27 day of December, (year) 2021 at NW 32TH AV/NW 4TH CT POMPANO BEACH, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

white Lexus sedan with no headlights on Sgt Mercado advised he could hear a scarping sound coming from the defendant's vehicle Sgt Mercado advised he observed that the defendant's vehicle sustained heavy front-end damage as well as the defendant was driving with the driver front tire completely flat driving on its rim Sgt Mercado observed the defendant swerve multiple times and was driving recklessly. Sgt Mercado advised when he made contact with the defendant, he observed the following signs of impairment glassy bloodshot eyes, odor of alcoholic beverage coming from the defendant's mouth, slurred speech Sgt Mercado advised that the defendant was unaware of the damage to her vehicle Sgt. Mercado advised the defendant said she had two glasses of champagne. Sgt Mercado requested me on scene to conduct a criminal DUI Investigation

Should be noted it is unknown what the defendant struck at this time

During my encounter with the defendant, I observed the following signs of impairment red glossy eyes, slurred speech, and a strong odor of alcoholic beverage coming from the defendant's mouth as she spoke with me. I asked the defendant what happened, and the defendant advised she was a party, and someone struck her vehicle The defendant advised she decided to operate her vehicle in that condition I asked the defendant if she had any alcoholic drinks tonight and the defendant advised that she had one glass of champagne I asked the defendant if she was willing to submit to some field sobriety exercises, the defendant advised that she would

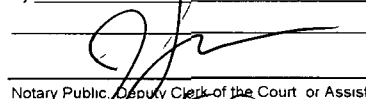
