 The defendant was operating a white 2020 Hyundai Sonata, 4 door, Florida tag PXPL91. The defendant failed to stop for a properly posted stop sign. Upon entering a City of Tampa parking garage, the defendant's vehicle right side tires drove over a raised curb. The defendant passed the ticket dispenser booth without taking a ticket, and the front bumper of her vehicle came too close to the lowered bar gate. The defendant had a blank look about her face. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant's speech was moderately slurred, she fumbled with items displaying poor dexterity, and was forgetful as related to documents requested. The defendant stated she drank one alcoholic beverage (beer) tonight. The defendant swayed while standing, and she dropped her cell phone from her hand onto the sidewalk. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after she was read the Implied Consent Warnings. The defendant was positively identified by her Florida DL.
