The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/13/2022 at approximately 0035 hours, a traffic stop was conducted on a white 2016 Toyota Rav4 with New York tag KRD7561 at the intersection of Dale Mabry Hwy N and Horatio St W after it was observed slow to response to several traffic signals, unable to maintain a single travel lane, operating with no headlights at night, made a un-singaled left turn, and violated the right of way of another vehicle when making the left turn (vehicle had to brake to avoid a collision). Contact was made with the driver/defendant who was observed to have bloodshot/glassy eyes, dilated pupils, slurred speech, had difficulty providing the requested documentation, was slow to response to basic questions, had a noticeable sway while he stood, and had the odor of an alcoholic beverage coming from his breath. He advised that he drank prior to driving. The defendant exhibited clues of impairment during SFTSs and was arrested for DUI. The defendant submitted to the requested breath testing which produced a BrAC of 0.239/0.242. The defendant was positively identified via DHSMV photograph. Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge.
