Before me this date personally appeared D'HAITI, DWAYNE D. (475) who being first duly sworn deposes and says that on 22 day of September (year) 2017 at 6800 MIRAMAR PKWY, MIRAMAR, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

I activated my emergency lights at the 4700 block of W Hallandale Beach Blvd and conducted a felony stop on the vehicle. The driver of the vehicle was identified as Sarah Dupont (DEF), who is also listed the registered owner of the vehicle. The vehicle was confirmed as stolen by Communications Officer Armstrong. Dupont was placed under arrest for grand theft auto.

An inventory of the vehicle revealed a pink wallet laying on the center console next to the gear shifter. The wallet contained a clear plastic bag which had a clear crystal substance suspected to be meth. The substance field tested positive for meth. The vehicle was towed by A&B Towing.

Dupont was transported to BSO Main Jail where she was left in the care and custody of BSO Deputies. The contraband was placed into property as evidence.
