I arrived on scene, both parties were separated, and I met with [REDACTED] who reported the following

Probable Cause Affidavit (Continuation)

Before me this date personally appeared H BAILEY, who being first duly sworn deposes and says that on the 16 day of May, (year) 2022, at (crime location) [REDACTED] the above-named defendant committed the above offenses charged, and the facts showing probable cause to believe the same are as follows

[REDACTED] and O'Day got into a verbal argument and while lying in bed, O'Day got irate and intentionally and against his will slapped him with open hands on his head and scratched him on his chest. He defended himself by grabbing her arms and in the process hit her in the face. She got up and threw everything off their nightstand. Both parties started pushing and shoving each other and continued to have a physical altercation after which [REDACTED] contacted this agency. I observed fresh, red marks on [REDACTED] chest that are consistent with someone being scratched. [REDACTED] refused medical treatment. I met with O'Day who provided the following: O'Day said that [REDACTED] accused her of cheating and called her "a slut, dog and a hoe". At some point [REDACTED] took her car keys away so she went out and bought another vehicle. Today [REDACTED] arrived home and was upset because he had an extra bill on his hands. He told her sleep on the couch because that's where dogs sleep. She went to bed and [REDACTED] went to the restroom, then came out and started cursing at her. He laid in bed and took his right arm and threw it in her face. She jumped out of bed and [REDACTED] grabbed her and intentionally punched her in the right eye against her will. She then ran to her daughter's room for safety. I observed a large, swollen knot above O'Day's right eye. She refused medical treatment. O'Day refused to provide a sworn digital statement but allowed photographs to be taken. I was unable to prove who was the primary aggressor due to the inconsistency of both party's statement. I placed both [REDACTED] and O'Day under arrest for Touch or Strike Battery (Domestic). Both parties were transported to Plantation PD jail for processing. [REDACTED] was read his Miranda Rights from a prepared Plantation PD document and provided a sworn digital statement of the incident while being processed at the Plantation PD jail. Photographs were taken of [REDACTED] and O'Day's injuries. [REDACTED] and O'Day were advised of their Marry's Victim's Rights to confidentiality, in which they both verbally invoked. The statement and photos were uploaded to the Plantation PD server. Both parties were provided domestic violence pamphlet. Both parties were taken to BSO Main for booking.
