The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did While conducting a related investigation, the defendant became belligerent and attempted to intervene in the arrest of another subject. One officer attempted to guide the defendant away with a touch but the defendant responded by shoving the officers hand away, swinging her left hand at the officer, and trying to push past. The first officer and another officer on scene attempted to obtain physical control of the defendant, but she continually pushed the officers away and flailed her arms and elbows in an attempt to resist. Both officers advised the defendant verbally multiple times to stop resisting during the incident. This incident occurred in a public parking garage and threatened the safety of the officers attempting to gain control of the defendant. At the time of the incident the defendant was intoxicated. The defendant was positively identified via FL DL.
