Probable Cause Affidavit

Before me this date personally appeared OFC M BUKATA, who being first duly sworn deposes and says that on the 12 day of SEPTEMBER, (year) 2021, at (crime location) 300-BLK SW 118TH AVE, the above-named defendant committed the above offenses charged, and the facts showing probable cause to believe the same are as follows

On Sunday 09/12/2021 I responded to the 300-BLK of SW 118th Ave in reference to a possible drunk driver slumped over at the wheel of a 2020 black Hyundai Elantra (FL tag [REDACTED]). An anonymous caller advised that the female was passed out at the wheel and that there was vomit on the ground next to her vehicle. Upon arrival I observed a white female, later identified as Sasha Jarufe, sleeping in the driver's seat of the vehicle. There was vomit on the street next to the driver's side door and remnants of the vomit on the black shirt and black pants that she was wearing.

Probable Cause Affidavit (Continuation)

Before me this date personally appeared OFC M BUKATA, who being first duly sworn deposes and says that on the 12 day of SEPTEMBER, (year) 2021, at (crime location) 300-BLK SW 118TH AVE the above-named defendant committed the above offenses charged, and the facts showing probable cause to believe the same are as follows

There was crash damage to her front left bumper and scratches to the right front passenger side to her vehicle

I was able to wake Sasha from her sleep. She appeared confused and was unable to understand simple commands. The keys were in the ignition and the car was still running. I told Sasha to exit the vehicle and she did not understand. Instead of exiting the vehicle, Sasha placed the gear switch in the neutral position. I commanded Sasha to place the vehicle in park several times before she finally did so.

Sasha's eyes were glossy and I was able to smell the odor of alcoholic beverages emitting from her breath. After several commands, she was able to exit the vehicle. She used the vehicle to maintain her balance during the course of my investigation. When she was not balancing herself on the vehicle, Sasha had an orbital sway and was stumbling while walking. Sasha was unable to articulate or advise when or where she was involved in a vehicular accident. Sasha only kept referring to her car as injured.

After determining that the crash may not have occurred in this location at this time, I advised Sasha that I was no longer conducting a crash investigation and that I was now conducting a DUI investigation.

She advised that she was on her way home from Fort Lauderdale but could not remember where. Sasha told me that she had "a few drinks" and did not eat enough this evening. Sasha was unable to tell me where she lived and only advised that she lives in Plantation. After further questioning she finally stated that she lives at the "800-BLK of NW 81st". I asked Sasha if she knew where she was and she stated that she was "in-between Nob Hill and University Island". The location of where Sasha was parked was approximately 37 blocks West of her desired destination and she was unaware of where she was.
