The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On this date and approximate time, at Tampa International Airport, truck court E, Hillsborough County, FL. The Defendant, identified as W/F Savannah F. Guillot, D.O.B. 02/22/1995, and B/M co-defendant, did enter the restricted area known as Truck Court E, as the gate was opened by a British Airways employee. The gate is clearly marked with a "No Trespassing" sign on the gate facing the roadway. In addition the gate is hard metal framed with concertina wire at the top and is a magnetic badge operated gate. The Defendant had a brown back pack and when challenged by the employee, the Defendant ignored the employee and attempted to open interior gates. Upon police arrival the Defendant was within the truck court and was taken into custody. A K-9 unit, Officer C. Reggi, K-9 Anya were dispatched to the scene for a sweep. There were no detections by K-9 Anya.
