The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/06/2021 at approximately 2138 hours, at Amalie Arena located at 401 Channelside Dr, while being removed from the property the defendant, Scarlett Frias-Morales, intentionally used her right hand to strike Tampa Police Officer M. Gardner's hand. The defendant was with a male subject who was removed by security due to his behavior.

The defendant, along with the subject who was removed, re-entered the property to retrieve a lost cell phone and walked past officers inside the arena. Officers contacted the male subject and began to escort him out of the Arena when the defendant began to cause a disturbance. Due to the defendant causing a disturbance officers attempted to escort her out of the building and verbally told her to leave. While guiding the defendant in the direction of the exit, the defendant intentionally used her right hand to strike the victim, Tampa Police Officer M. Gardner's hands, against her will.

The incident occurred in the presence of multiple Officers and the defendant was arrested and charged with Battery on a Law Enforcement Officer.

The defendant was positively identified via Florida Driver's License.
