The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
The defendant was driving a black 2016 Ford Mustang bearing a Florida license plate of IVIV73. He was traveling west on Kennedy Blvd between N MacDill Ave and N Dale Mabry Hwy and was weaving back and forth multiple times, driving at inconsistent speeds from 40 to 50 MPH in a posted 40 MPH zone, and ran a red light at Dale Mabry Hwy. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, flushed face, slurred speech, unable to divide his attention, stopped talking mid sentence when I asked him a question, a strong odor of an alcoholic beverage, and an admission to consuming alcohol, but would not answer how much he had to drink. The defendant refused to perform SFSEs. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant has a prior refusal to submit to breath, urine, or blood testing on 03/30/2011.

The defendant was identified by his FL DL.
