The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 6/5/2022, at 0319 hours, Sergeant L. Rudolph ABN 222624 conducted a traffic stop on a gray Ford truck, bearing FL tag Z405TI (VIN: 1FTFW1EF1BFC70396) at E Adamo Dr / S Falkenburg Rd for a welfare check. Sergeant L. Rudolph made contact with the defendant who was in the driver's seat and the sole occupant. Sergeant L. Rudolph observed the defendant to have signs of impairment. I responded to the scene, detected signs of impairment from the defendant, such as glassy/watery eyes, unsteady balance, slow/lethargic movements, and the distinct odor of an alcoholic beverage emanating from the defendant's breath. The defendant was asked to participate in the Standardized Field Sobriety Exercises, to which he refused. The Defendant was placed under arrest for DUI. Once at Central Breath Testing, the defendant refused to provide a lawful breath sample to determine his breath alcohol content (BrAC) after being advised of the Implied Consent Warning. The defendant was positively identified via FL DL.
