The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On May 29, 2022 at approximately 0426 hours, I observed a light blue Acura TSX bearing Florida license plate#: L4GPY (VIN: JH4CU26649C030766) traveling westbound on Fletcher Avenue East with no headlights on in violation of F.S.S. 316.217(1)(a). The vehicle activated it's flashing hazard lights, then turned them off, then activated them, then turned them off again. I conducted a traffic stop and made contact with the defendant (driver). Upon contact, I observed the defendant to have glassy eyes and I detected the strong odor of an alcoholic beverage emanating from her breath. The defendant also believed her headlights were on while she operating her vehicle. The defendant performed standardized field sobriety exercises poorly indicating impairment. A check of the defendant's vehicle yielded an open bottle of Hennessy liquor in the center console cup holder and cold Modelo Especial beers in the center rear passenger seat. There were empty bottles of beer mixed in with the full bottles. Once at Central Breath Testing, after a twenty-minute observation period and after being advised of the Implied Consent Warning, the defendant provided lawful breath samples showing a breath alcohol concentration of .153/.158. I confirmed the defendant's identity via DAVID.
