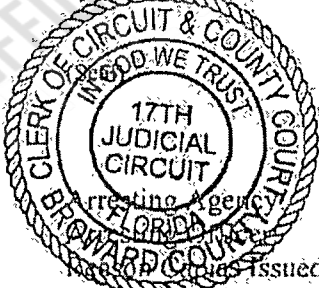

Probable Cause Affidavit

Before me this date personally appeared ROCKEY, ERICA (17035) who being first duly sworn deposes and says that on 27 day of May (year) 2017 at 1100 E SAMPLE RD, POMPANO BEACH, FL 33064 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Juvenile-1 is friends with twelve year old, [REDACTED] and has known her for several years. On May 10, 2017 Juvenile-1 was having a birthday party at her house. On this date in the early afternoon, Machado picked up [REDACTED] from her place of residence, 2820 NE 7th Ter, Pompano Beach, FL 33064. There was no one else inside the vehicle at the time, and Juvenile-1 was already at the party. When [REDACTED] got inside the vehicle, Machado asked her for a hug, and [REDACTED] hugged him. Machado began telling [REDACTED] how much he loves her, and [REDACTED] did not respond. Machado then began driving to the party and began engaging in conversation with [REDACTED]. Machado asked [REDACTED] why she always wears a jacket, and suggested that she should take it off. [REDACTED] told Machado that she didn't want to take off her jacket. Machado then pulled the vehicle over to the side of the Sample road and placed the vehicle in park. When the vehicle was parked, Machado asked [REDACTED] to give him another hug. [REDACTED] gave Machado a hug, at which time he began kissing [REDACTED]'s neck. [REDACTED] said that she could feel Machado open his mouth while he was kissing her on the right side of her neck. Machado asked [REDACTED] to show him her stomach and [REDACTED] refused. [REDACTED] stated during her sworn statement, that throughout the incident she was scared and felt like crying. [REDACTED] pushed Machado off of her and he stopped what he was doing. Machado then pulled back onto the road and continued driving back to the party. Once at the party (3750 NE 12th Ave, Pompano Beach), [REDACTED] told Juvenile-1 what happened inside the vehicle with Machado. Juvenile-1 admitted in a statement that she was going to tell her mother, but she forgot. The following day, [REDACTED] told her mother, Ana Paula Pereira.

On a separate occasion, which occurred a few months prior, at about 1600 hrs, Machado arrived at [REDACTED]'s residence, while [REDACTED]'s mother, Pereira was not home.

Probable Cause Affidavit

Before me this date personally appeared, ROCKEY, ERICA (17035) who being first duly sworn deposes and says that on 27 day of May, (year) 2017, at 1100 E SAMPLE RD, POMPANO BEACH, FL 33064 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

██████████ let Machado inside the residence at which time he began asking ██████████ to take "sexy" pictures for him. Pereira usually arrives at the house at about 1730 hrs. On this date, Pereira got off of work early and arrived home to find Machado inside her living room talking with ██████████.

Through investigative means, a recording was obtained where Pereira had a telephone conversation with Machado. In this conversation, Machado admitted to kissing ██████████ on the neck while he was driving her to his house, but explains that he must have slipped, because he was trying to kiss her cheek, which is how he normally greets everyone.

In a post Miranda interview with Machado, he admitted to picking up ██████████ to drive her over to Juvenile-1's residence. During this drive, he admits to pulling the vehicle over to the side of the road. He explained that he did ask ██████████ to take off her jacket, but only because he was concerned about her, and it was hot outside. Machado said that he wanted to talk to ██████████ because she has been very depressed. ██████████ was very dismissive and he gave her a hug with a kiss on the cheek as he does with all of his family and friends. Machado would not admit to kissing ██████████ on the neck as he did in the aforementioned recording. Additionally, Machado did admit to going over to ██████████'s residence a few months prior when her mother, Pereira, was not home. Machado, who has known ██████████ for almost seven years, thinks of himself as a father figure to ██████████. Machado had heard that ██████████ was sending "sexy" pictures to boys at her school and he went to talk to her about his concerns. When he arrived at their house, and Pereira was not home, he didn't think anything of it and had a talk with ██████████. Shortly thereafter, Pereira arrived home. Machado insists that he

Machado's statement to law enforcement is identical in many ways to [REDACTED]'s; he admits to pulling over to the side of the road and asking [REDACTED] to take off her jacket, he admits to asking her to take off her jacket, and he admits to hugging and kissing her, but he does not admit to kissing [REDACTED] in a sexual manner or even on the neck. This contradicts the recoding obtained where Machado admits to slipping and kissing [REDACTED] on the neck accidentally.
