

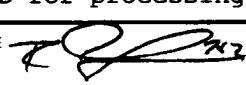
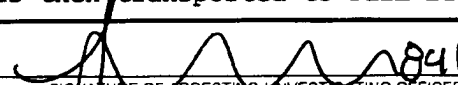

On 06/05/2022 at approximately 0346 hours, I responded to the area of 131 E Palmetto Park Road in reference to a domestic disturbance. Upon arrival, I met with [REDACTED] and W/M Shalom Aviser (DOB 06/29/1977) on the southside of the roadway. Both Aviser and [REDACTED] advised they were in a verbal argument regarding who would be the one driving home after a night out at the bar. Both parties appeared to have been intoxicated. [REDACTED] had a laceration on the bottom-left of her lip. [REDACTED] also appeared to have had a bloody right nostril. [REDACTED] was adamant the altercation did not get physical from either party. Shalom also was adamant about the altercation not turning physical between the two. Shalom appeared to have had dry blood on his nose, however no apparent injury to his nose. Shalom had a small laceration on his right collar bone, however, was adamant from his own doing. Both parties denied medical attention. W1 advised he saw an unknown W/M, last seen wearing an orange shirt, blue jeans with brown hair "beating up" an unknown W/F last seen wearing a black dress. Both of the subjects matched the description provided by W1 and were at the exact location provided by the witness. W1 stated Shalom was hitting the victim repeatedly all over her body, on the southside of E Palmetto Park Road. W1 stated at no point did he see the victim physically batter Shalom. W1 provided a sworn statement via landline and advised he was just another patron from the local bar. Due to the injuries and an independent witness, Shalom was placed under arrest, under F.S.S. 784.03(1A1) simple battery. Shalom struck the victim against her will leaving injury to her person. Shalom was placed into BRPD handcuffs, which were double-locked and checked for tightness. Shalom was placed into my marked BRPD patrol vehicle and transported to the PD for processing. Shalom was then transported to Palm Beach County
