PROBABLE CAUSE

Before me this date personally appeared, Ofc K Balladares 839 who being first duly sworn deposes and says that on the 20 day of September, 2017 at 12600 Pines Blvd, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

A call for service regarding a reckless driver in the area of Pines Blvd and Hiatus Road west bound came over dispatch. The vehicle description involved a small silver vehicle swerving all over the roadway heading west bound with a Virginia tag of VRW4818. At the same time the call was put over the radio, I noticed I was in the exact area of where the vehicle was last seen. I was currently in the west bound inside lane of Pines Blvd at approx 11800 Pines Blvd when I looked over to my right and saw that exact vehicle description pass my marked police vehicle in the center lane west bound. As I advised on the radio that I was in the area, I began to follow the vehicle to observe the vehicle in motion and driving pattern. The vehicle immediately began to gain speed as it went through a green light on Flamingo Road and Pines Blvd. I paced clocked the vehicle at 62MPH in a 45MPH zone. The vehicle was crossing over the center lane line passing it's tires over into the outside lane, and then back into the center lane three times with multiple vehicles surrounding the car. In fear of the vehicle striking another car, I immediately turned on my emergency equipment once the vehicle passed through Flamingo Road and Pines Blvd intersection in the center lane. The vehicle slowed and pulled over to the right shoulder at approx the 12600 Block of Pines Blvd.

I approached the vehicle via driver side window. As I approached, I observed three people inside the vehicle. Contact was made with the driver/Click. An odor of alcohol was emitting from the interior of the vehicle and I observed bright orange wrist bands that looked as if they were given from a bar on all occupant's hands inside the vehicle. I asked Click for her drivers license, registration and insurance to which she gave me her drivers license and registration. Click was identified via her Virginia DL. I asked her again for her insurance and it appeared as if she forgot. She then stated "Oh I don't have it". I asked her where she was headed and she stated "Boynton Beach". I asked where she was coming from and she stated "Round Up". It should be noted, Round up is a night club in Davie. I then asked Click if she had anything to drink tonight and she stated, "nothing at all". She began to stumble on words and appeared nervous as she spoke with me. Click's eyes were bloodshot and glassy. At that point in time, I asked Click if she would step out of the vehicle to speak with me and she stated "yes". Click exited the vehicle and walked almost into oncoming traffic. I diverted her to the rear of her vehicle. Click was unstable on her feet. As I spoke with Click up close, a strong odor of an alcoholic beverage was emitting from Click's mouth. I asked Click if she had any medical or physical conditions I needed to be aware of and she stated "No". Click advised she last ate earlier in the night and slept the night prior. She advised she was on no medication. I asked Click if she knew where she was currently at and she stated "No idea". I then asked Click if she was willing to submit to the SFSE's and she stated "Yes". Conditions were night time on a dim lit road, flat and clear of debris. A white solid lane line was used for the WAT. My emergency lights were set to rear mode only. Results are as follows:

HGN Equal tracking/ equal pupil size (orbital sway)
1 The def displayed lack of smooth pursuit in each eye
2 The def displayed Nystagmus at maximum deviation in both eyes
3 The def displayed Nystagmus onset prior to 45 degrees in both eyes
Vertical Nystagmus was present (6 out of 6 clues)

WAT
1 The def was unable to remain in the starting position
2 The def began the exercise too soon
3 The def crossed her feet each step, not heel to toe with an approx 3 inch gap
4 The def stepped off the line every other step
5 The def stumbled off the line during the turn
(5 out of 8 clues)

OLS Left foot
1 The def placed her foot down after the 11th second
2 The def swayed side to side
3 The def began to hop
(3 out of 4 clues)

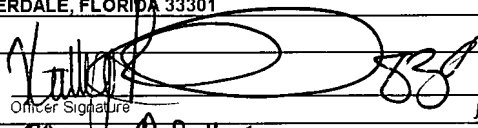
