Narrative:

On Tuesday August 9th, 2022 at approximately 0205 hours, I responded to the area of _____ in reference to a disturbance.

Upon arrival I made contact with _____ who advised that him and _____ later identified as W/F Shannon J. Dawson (DOB: 10/24/1976), _____ had gotten into a verbal argument, which became physical. _____ advised that he was sleeping on the couch when Dawson jumped on him to grab his phone. _____ advised that he pushed Dawson off of him in self-defense and in the process tore her shirt. _____ advised that during this struggle Dawson had bit him on the left bicep (pictures captured via BWC) causing a small laceration and bleeding. _____ refused medical treatment.

I spoke with Dawson who advised that she was talking with _____ when he attacked her by grabbing her throat and throwing her onto the ground. Dawson advised that _____ then ripped her clothes off, but did not know where this event took place or where the clothes were. A two ripped shirts were found (pictures captured via BWC). Upon examining Dawson, I noticed no marks consistent with being choked and thrown to the ground on her neck or body (pictures captured via BWC). It should be noted that while speaking with Dawson she changed her story several times.

Based on the above investigation, lack of evidence to corroborate Dawson's version of the story, her inconsistent statements and lack independent witnesses, Dawson was determined to be the aggressor and was placed under arrest for Simple Battery (Domestic) F.S. 784.03. Dawson was placed in handcuffs (checked for fitment and double-locked) and transported to BBPD Booking and then to PBCJ.

_____ completed a Marsy's Form (INVOKED) along with an Exemption from Public Records form. _____ was provided a domestic violence pamphlet. Incident was captured via BWC.
