The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 6/14/2022, at approximately 2341 hours, the defendant was operating a white Ford bearing FL tag HEAT4ME (VIN:1FM5K8HT8GGB59178) traveling northbound on Veterans Expy N. The white Ford lost control, drove through barricades to the express lane, struck the center median, losing the front passenger tire, and came to a final rest in the right thru lane of travel. The witnesses observed the traffic crash and positively identified the defendant as the person that was operating the white Ford at the time of the traffic crash. Deputy J. Town ABN 257658 conducted the traffic crash investigation (Reference HCSO event #22- 464196, DHSMV #24636685. Affiant responded to the scene, made contact with the defendant and detected the distinct odor of an alcoholic beverage emanating from her breath, her eyes were bloodshot and glassy, and she was unsteady on her feet. Affiant requested the defendant perform Standardized Field Sobriety Exercises which the defendant refused to perform, and was subsequently arrested for DUI. The defendant refused to provide a breath sample, therefore Affiant read Implied Consent to the defendant, she acknowledged verbally she understood, and replied "No.". The defendant was identified via FL DL. The total property damage as a result of the traffic crash was \$10,000. The defendant was given DUI citation AGBB9HE which reflects the DUI charge.
