On 07/27/2022 at approximately 10:09pm Trooper Perez (In training) and I, Trooper Masterson were dispatched to a crash northbound on Interstate 95 south of State Road 704 (Okeechobee Blvd). Upon my arrival, I observed two vehicles on the right shoulder. Vehicle one was a fiat spider bearing license plate #(LVLETLV) and Vehicle two was a Chevy traverse bearing license plate #(HVYJ77). The driver of Vehicle one was identified as SHERI,MARIE,FIELDS-PALERMO (F-432-793-68-663-0). Ms. Fields-Palermo was sitting in the driver seat speaking to someone on the phone when I initially approached her. The driver of vehicle two who I identified as Maegan Serrette was standing outside of her vehicle and stated to me that Ms. Fields-Palermo was the driver of Vehicle one. A witness statement is attached. Palm Beach fire rescue responded to the scene. All parties including Ms. Fields-Palermo refused medical attention.

During the crash investigation I observed signs of impairment from Ms. Fields-Palermo. I first noticed the odor of unknown alcoholic beverage. I had Ms. Fields-Palermo step out of the vehicle to identify where the odor was originating from. Even while outside, I could still smell an obvious odor of unknown alcoholic beverage emitting from Ms. Fields-Palermo breath. Ms. Fields-Palermo was very lethargic and had slurred speech. I asked Ms. Fields-Palermo which lane of travel she was in and she forgot the question I asked her almost immediately. Ms. Fields-Palermo stumbled as she stepped out of her vehicle. Ms. Fields-Palermo also didn't know where she was. Ms. Fields-Palermo stated she was south of Palm beach lakes. Ms. Fields-Palermo was south of Okeechobee Blvd. We were less than a quarter mile from the intersection on the exit ramp. Ms. Fields-Palermo kept forgetting where she was and couldn't remember questions that were just asked to her. Ms. Fields-Palermo eyes were blood shot and glossy and her face was very flush.

I advised Ms. Fields-Palermo that I concluded my crash investigation and was now conducting a DUI investigation. Ms. Fields-Palermo stated she understood. I read Ms. Fields-Palermo's her Miranda rights. Ms. Fields-Palermo stated she understood her rights. I asked Ms. Fields-Palermo where she was coming from. Ms. Fields-Palermo stated she was coming from work at Saint Mary's

hospital. Saint Mary's Hospital is located on 45th Street and Greenwood Ave which is 3 exits north of our current location. I asked Ms. Fields-Palermo if she suffered from any illness or medical conditions. I asked Ms. Fields-Palermo if she suffered from diabetes, strokes, and seizures. She stated she did not. I asked Ms. Fields-Palermo if she suffered any injuries from the crash and she stated she did not. I asked Ms. Fields-Palermo if she would like to perform a series of voluntary Standardized Field Sobriety Exercises. Ms. Fields-Palermo did not agree to SFST. I advised Ms. Fields-Palermo of her Taylor Warning. I explained to Ms. Fields-Palermo that SFST was an opportunity to prove her sobriety level. Ms. Fields-Palermo still did not want to do SFST. I explained to Ms. Fields-Palermo that without doing SFST that the DUI investigation would have to only rely on the impairment that was observed during the crash investigation and the DUI. We advised Ms. Fields-Palermo of the observation that was made (Smell of unknown alcoholic beverage emitting from her breath, blood shot watery eyes, flush face, slurred speech, swaying and unbalance, forgetful, repetitive, incorrect sense of location). Ms. Fields-Palermo was uncooperative and carefree. Ms. Fields-Palermo would have mood swings of carefree and irritated. She stated that we were trying to force her to do the exercises but did not know how to explain how or why she felt that way. I asked Ms. Fields-Palermo if she would like to participate in voluntary SFTS one more time after advising her. Ms. Fields-Palermo still did not want to participate in SFST.

l arrested Fields-Palermo for DUI at 11:11pm. We advised Ms. Fields-Palermo she was under arrest for DUI. Ms. Fields-Palermo stated she understood. Ms. Fields-Palermo was still carefree and even laughing. We conducted a search of Ms. Fields-Palermo. We then placed Ms. Fields-Palermo in the patrol car. While Ms. Fields-Palermo was in the patrol car, she filled the vehicle up with the odor of an unknown alcoholic beverage that was not present prior to her entering. Ms. Fields-Palermo displayed mood swings while being transported to the BAT. Ms. Fields-Palermo was angry and irritated, then was laughing, then sad and crying, then calm and quiet. At the BAT, Ms. Fields-Palermo underwent a 20-minute observation period. Ms. Fields-Palermo did not take anything by mouth or regurgitate. After the 20 minutes observation period I asked Ms. Fields-Palermo if

she will take the breath test. Ms. Fields-Palermo stated no. I read implied consent to Ms. Fields-Palermo. Ms. Fields-Palermo stated she understood. I asked Ms. Fields-Palermo if she will take the breath test again. Ms. Fields-Palermo still refused.

Ms. Fields-Palermo was then transported to Good Samaritan west hospital for jail clearance and then transported back to the jail. Ms. Fields-Palermo was released to PBSO custody. There was no further incident. All events occurrent in Palm Beach County. All events were recorded on FHP1706.
