<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On 07/07/2022, at approximately 2126 hours, the affiant observed a blue Mercedes coupe, bearing Florida tag 17AYLV (VIN:WDDJK7DA7EF026177), parked in the grass/bushes outside of the above location. The affiant stopped to check on the welfare of the driver/defendant and observed him passed out behind the wheel of the vehicle. The vehicle's accessory lights were on and the keys were nearby in the front passenger seat. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath, observed his eyes to be red/bloodshot and watery, and him to have unsteady balance. The affiant requested the defendant to perform Standardized Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT, where he refused to provide lawful breath samples after Implied Consent was read and understood. The defendant was positively identified via his Florida driver' license.</p>
