The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a black 2010 Kia four-door bearing a Florida license plate of IP10FD. He was traveling west on E 2nd Ave near N 19th St and was driving without headlights on. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, unsteady stance, unsteady walk, and an admission to consuming alcohol (two beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning. The defendant was identified by his FL DL.
