The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the listed date and time, at 209 E Knights Griffin Rd within Hillsborough County, the affiant responded to a traffic crash call for service reference an impaired driver (#22-276488). The witness observed the defendant in the driver seat at the time of the traffic crash. Deputy M. Bruce #255188 made contact with the driver and observed indicators of impairment. The total value of the victim's property damage was approximately \$500. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his breath, had slight slurred speech, had bloodshot and watery eyes, had dry mouth, and an unstable balance. Field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples after Implied Consent warning was read and understood.
