The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/15/2022, at approximately 0426 hours, the affiant observed a red Toyota Tundra, bearing Florida tag Y985NT (VIN:5TFBY5F17EX341456), traveling in front of his HCSO issued patrol vehicle. The affiant observed the red Toyota Tundra drifting in and out of it's lane of travel, rapidly accelerating, conducting wide turns, and nearly leaving the roadway. The affiant conducted a traffic stop on the red Toyota Tundra to check the welfare of the driver: to see if they were ill, tired, or impaired. Upon contact with the driver/defendant, the affiant detected the strong odor of an alcoholic beverage emanating from his breath, observed his eyes to be red/bloodshot and watery, his speech to be slurred, his movements to be slow and lethargic, him to fumble for requested documents, and him to have unsteady balance. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT, where he refused to provide lawful samples of his breath after Implied Consent was read and understood. The defendant was positively identified via his Florida driver's license.
