Probable Cause

- I. WHAT: Boating Under the Influence of Alcohol / Operating a vessel with a BAL over .15
- II. WHEN: 7/3/2022 at approximately 1900hrs
- III. WHERE: East of Jupiter Beach Club on the beach. Jupiter, Palm Beach County
- IV. WHO: Steven Bruce McConnell 03/27/1976
- VI. DETAILS OF BUI
- A. Phase 1 Initial Observation of vessel in operation

Vessel was involved in a boating accident and was aground on the beach when I arrived on scene. An independent wheel witness identified the operator as Steven Bruce McConnell. McConnell was the sole occupant of the vessel.

B. Phase 2 - Personal Contact with operator of vessel

After Officer Riggs completed his investigation of the boating accident, I identified myself and notified McConnel I was starting a criminal investigation for boating under the influence. McConnell's face was flushed, his eyes were extremely bloodshot, glassy, and his eyelids were droopy. Post Miranda warning, McConnell admitted to drinking, operating the vessel, and being the sole occupant. McConnell was extremely confused about the time of day and when he started his day on the water Based on the obvious signs of impairment I requested McConnel to conduct standardized field sobriety task. He complied.
