The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was located passed out behind the wheel of a silver Honda SUV bearing FL tag HGQV40 with the engine running, in gear and his foot on the brake pedal. A concerned citizen called for police service to check on the welfare of the defendant. Upon contact, the defendant was disoriented and exhibited indicators of impairment to include bloodshot and glassy eyes, slurred speech and the odor of an alcoholic beverage emanating from his breath. The defendant had a pink bar bracelet on his right wrist, was unsteady on his feet and admitted to drinking. The defendant participated in SFSE's, which showed further indicators of impairment, and was subsequently arrested for DUI.
