As we were attempting to wake him up, Crisci (Def) became combative and insisted on going back into the entrance. At that point, Officer Cimino and Sgt Navarro went to place Crisci (Def) into custody and he resisted their efforts by pulling away, stiffening his arms and not complying with their orders. Crisci (Def) was eventually subdued and had to be physically carried to the police unit. While at the police car, Crisci (Def) refused to get into the vehicle and had to be physically pushed in. Crisci (Def) was arrested, charged accordingly and transported to the Broward County Jail.
