

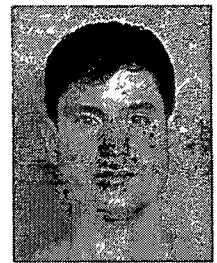

Before me this date personally appeared MCBAYNE, LASHONNE (100000) who being first duly sworn deposes and says that on 27 day of February, (year) 2022 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On 2/27/22 Mr. Crisci (Def) was a patron of Daer Night Club which is located at 5704 Seminole Way. Crisci (Def) was extremely intoxicated and was causing a disturbance and was asked to leave the club. At first he refused but eventually got into a cab and left.

Approximately one hour later, security personnel brought to our attention that Crisci (Def) had returned and was now sleeping in the bushes, just outside of the Lucky Street

Before me this date personally appeared MCBAYNE, LASHONNE (100000) who being first duly sworn deposes and says that on 27 day of February, (year) 2022 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Valet exit doors.

As we were attempting to wake him up, Crisci (Def) became combative and insisted on going back into the entrance. When officers attempted to keep Crisci (Def) from going into the venue, he pulled away and began to resist the officers efforts by pulling away and push away from the officers. At that point, Officer Cimino and Sgt Navarro went to place Crisci (Def) into custody and he resisted their efforts by pulling away, stiffening his arms and not complying with their orders.

Crisci (Def) was eventually subdued and had to be physically carried to the police unit. While at the police car, Crisci (Def) refused to get into the vehicle and had to be physically pushed in. Crisci (Def) was arrested, charged accordingly and transported to the Broward County Jail.
