On 06/08/2022 at approximately 2255 hours, this Officer was in the area of Alt A1A and RCA Blvd, PBG, FL, when a vehicle was observed traveling at an increased rate of speed north bound in the outside through lane. Body worn camera and in car video were used in the investigation. After the light at the intersection changed to green, this Officer observed the lead vehicle, a BMW sedan (HLV814/SC) accelerate much quicker than the two vehicles to its rear. This Officer's initial visual estimation of the vehicle, was approximately 65 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), front antenna (KC086606) this Officer received a steady tone and reading of 65 MPH, as the vehicle passed through the intersection of Alt A1A and PGA Pass, PBG, FL. The RADAR calibration was last checked on 05/09/2022 and was due on 11/09/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer observed the vehicle make a left-hand turn onto Gardens Pkwy then a left-hand turn onto Valencia Gardens Av, where the traffic stop was conducted. This Officer made contact with the driver and sole occupant, identified via Florida driver license photo Summer Lawson (OF) while she was still in actual physical control of same. Lawson had red watery eyes, slurred speech, flushed face, and the moderate obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. This odor significantly increased as Lawson spoke with this Officer and as the investigation progressed. Lawson provided this Officer with two different copies of the vehicle insurance rather than the registration. Lawson appeared unaware she was speeding and apologized for "going 65 over". Lawson said she had "a cocktail" at Pirate's Well while having dinner at that location.

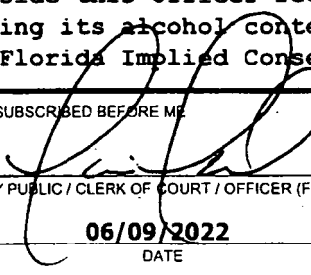

Based on this Officer's observations, Lawson was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. Lawson said she did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight. This Officer observed a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Lawson also had the onset of Nystagmus in both eyes prior to 45 degrees as well as Vertical Gaze Nystagmus in both eyes. Lawson had to be told multiple times to keep her head still and to follow the stimulus the prior way. The second exercise conducted, was the Walk and Turn. The line used, was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Lawson stepped out of the starting position and was told to get back into the position. Lawson also started the exercise twice prior to being told to do so. During the first set of steps, Lawson raised her arms more than six inches from her sides. After the turnaround, Lawson paused to compose herself prior to starting. During the return set of steps, Lawson placed her lead foot next to her planted foot on her first step then moved same to the line. Lawson again had her arms raised more than six inches from her sides. The third exercise conducted, was the One-Leg Stand. During the exercise, Lawson raised her right foot. Lawson swayed throughout the exercise and raised her arms more than six inches from her sides. On count "13" Lawson placed her foot down and asked for further instruction. Lawson then stumbled back and took an extended time to raise her foot again. Once she raised her foot, Lawson again swayed and raised her arms more than six inches from her sides. The fourth exercise conducted, was the Finger to Nose. When told to begin, Lawson did not close her eyes. On the first command of Left, Lawson touched under the tip of her nose, then the tip of her nose and opened her eyes. First command of Right, Lawson used the pad of her finger to touch her nose. Second command of Left, Lawson used the pad of her finger to touch her nose. The third command of Left, Lawson tilted her head forward, touched the right side of her nose, then corrected herself to the tip of her nose. The final exercise conducted, was the Rhomberg Alphabet. During the exercise, Lawson was orbitally swaying. Based on this Officer's observations, Lawson was placed under arrest at 2311 hours. On the roadside this Officer requested Lawson to provide a breath sample for the purpose of determining its alcohol content, to which she refused. This Officer read Lawson updated Florida Implied Consent, via Florida DOT cards, to which she acknowledged and
