THE INFLUENCE OF ALCOHOLIC BEVERAGE OR CONTROLLED SUBSTANCE TO THE EXTENT THAT HER NORMAL FACULTIES WERE IMPAIRED, OR WITH A BLOOD ALCOHOL LEVEL OF 0.08 PERCENT, TO-WIT, REFUSAL.

ON 04/19/2022 AT APPROXIMATELY 2343 HOURS I RESPONDED TO N STATE RD 7 AND JOHNSON ST TO BACKUP OFC TERAZON #3556 ON A TRAFFIC STOP SEE HIS SUPPLEMENTAL REPORT FOR FURTHER

UPON MY ARRIVAL ON SCENE, OFC TERAZON INFORMED ME THAT HE BELIEVES THAT THE DRIVER OF THE VEHICLE SUMMER LYNN MADDEN WHO WILL GOING FORWARD BE REFERRED TO AS ARRESTEE IS IMPAIRED.

I THEN PLACED THE ARRESTEE INTO CUSTODY AT 2358 HOURS FOR DUI I ASKED THE ARRESTEE IF SHE WOULD SUBMIT TO A LAWFUL TEST OF HER BREATH AND SHE REFUSED I THEN READ THE ARRESTEE IMPLIED CONSENT FROM A PREPARED TEXT IN THE PRESENCE OF OFC TERAZON AND THE ARRESTEE REFUSED AGAIN
