The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

At the above time, date, and location, the Defendant knowingly and intentionally struck both victims against their will. The defendant struck the first victim multiple times with open hands and closed fists on the upper portion of his body while inside her residence. The defendant swung at the second victim with an unknown hand and struck her on the right side of her jaw causing a minor laceration that did not require medical attention. The defendant is the biological mother of one of the victims and is the mother-in-law to the other. Both victims identified the defendant as the individual committing the offense.
