The defendant was observed by OFC G. Landry to be driving a silver 2020 Lexus 4-door (FL Tag #76AGCN) southbound on Howard AV S from Kennedy Bl W. This section of Howard Av S is a 1-way road with northbound traffic only. After turning around, the vehicle then proceeded eastbound on Kennedy Bl W and stopped at the red light at Rome Av S. When the light turned green, the vehicle sat and did not move.

During the traffic stop for the wrong-way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, disoriented, confusion, appeared tired/lethargic, poor balance, poor coordination, admitted to having "2 vodka/cranberry drinks" at a bar in Soho prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking.

While at CBT, she was read Implied Consent, but refused to take a breath test.
