The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a silver 2020 Toyota Camry, 4 door, Florida tag QGCY19. The defendant drove at a speed of 50 -52 MPH in a properly posted 40 MPH speed limit, which was visually estimated and patrol car paced (TPD DUI unit 5055). The defendant then entered a right turn only lane, but did not make the right turn at the end of the lane and continued straight from the right turn only lane, crossing through the painted right shoulder on the opposite side of the intersection. The defendant's registration showed (via DHSMV computer check prior to the traffic stop) as having expired on 10/19/2021. A traffic stop was conducted. The defendant had a confused and dazed look. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was slurred. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant displayed cognitive issues as he could not remember what documents he had been asked to present as he asked several times what it was that was needed. The defendant stated that he did consume alcoholic beverages (beer) tonight. An empty White Claw alcoholic beverage can was observed in plain view in the back passenger side floorboard. The defendant was unsteady exiting the vehicle, and he swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. During an impound/inventory search of the vehicle a Yeti style glass was located hidden behind a backpack in the passenger side front seat. This cup contained ice and a clear liquid that had a distinct smell of an alcoholic beverage. The defendant provided breath samples of .255% BrAC and .256% BrAC. The defendant was positively identified by his Florida DL.
