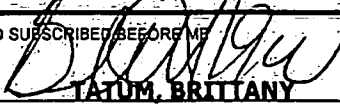
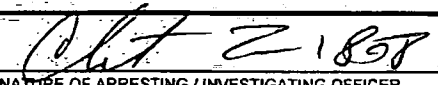
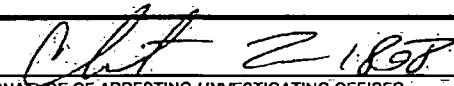

On the 16 day of September, 2021 at 14:49 (Specifically include facts constituting cause for arrest.) On September 5, 2021, the crime of Neglect Child Without Great Bodily Harm was reported to the City of West Palm Beach Police Department. A 3-year-old child, [REDACTED] was left unattended and nearly drowned in the Briar Bay community pool. Briar Bay Security Supervisor, William Valega, showed Officer Annese the video surveillance video covering the pool area. Valega told West Palm Beach Police Officer Annese the [REDACTED] VICTIM that nearly drowned was named [REDACTED] who resides at [REDACTED] WITNESS 1, Mary Jo Walsh, who has over 20 years of nursing experience, and a pediatric nurse for approximately 14 years, provided a sworn statement. While in the pool she observed the VICTIM as approximately 2-3 years of age in the shallow end of the pool traveling toward the deeper end. She scanned the area but was unable to see who was watching her. She later observed her daughter, 14-year-old Evelyn Walsh-Watson (WITNESS 2), walking quickly through the water, carrying the unconscious VICTIM, on her back, toward the edge of the pool. WITNESS 2 placed the VICTIM on the pool deck, WITNESS 1 described the VICTIM as vomiting a "Huge" amount of water, approximately a half gallon of water. She observed the VICTIM having a distended abdomen and very pale. She observed the [REDACTED] rush over and assisting the VICTIM in standing. The VICTIM vomited a large amount of water again. WITNESS 2 provided a sworn statement saying while in the pool, she observed a 2 ½ year old child in the 3-foot area of the pool on her back gasping for air with her head slightly under water. Witness 2 picked the VICTIM up out of the water and noticed she was not moving, unconscious, her lips were blue, and her face was pale. WITNESS 2 also described the VICTIM vomiting frothy water. WITNESS 2 stated the VICTIM's [REDACTED] rushed

over asking "What happened?" Tanya Chaves [REDACTED] where the VICTIM was admitted overnight for observation. [REDACTED] provided a sworn statement saying that day [REDACTED] had gone to the beach and later to the community pool without the VICTIM'S flotation aids. She advised [REDACTED] but no formal swim lessons were in place. She stated the VICTIM likes to drink the water. A review of the pool surveillance camera revealed the VICTIM in the pool alone and unattended prior to the 3:54:10 time stamp. The VICTIM appears to become stationary approximately 1:45 later. The VICTIM appears to go beneath the water's surface approximately 12 seconds after and is eventually pulled out of the water 3:07 after the beginning of the footage. No adults were seen with, or in the area of the VICTIM during the time she was seen in the pool. Based on the aforementioned information, [REDACTED] failed to supervise the VICTIM while in the pool, knowing the VICTIM did not know how to swim and was not utilizing any water safety device(s). Based on the DEFENDANTS negligent action, the VICTIM nearly drowned, but survived after asphyxia due to submersion. I find Probable Cause exists for the arrest of Tanya Chaves 3-25-1986 for Neglect Child Without Great Bodily Harm per F.S.S. 827.03(2D).
