Valega told West Palm Beach Police Officer Annese the VICTIM that nearly drowned was named who resides at WITNESS 1, Mary Jo Walsh, who has over 20 years of nursing experience, and a pediatric nurse for approximately 14 years, provided a sworn statement. While in the pool she observed the VICTIM as approximately 2-3 years of age in the shallow end of the pool traveling toward the deeper end. She scanned the area but was unable to see who was watching her. She later observed her daughter, 14-year-old Evelyn Walsh-Watson (WITNESS 2), walking quickly through the water, carrying the unconscious VICTIM, on her back, toward the edge of the pool. WITNESS 2 placed the VICTIM on the pool deck, WITNESS 1 described the VICTIM as vomiting a "Huge" amount of water, approximately a half
