being impaired and I was requested to conduct a DUI investigation Upon arrival, I made contact with Deputy Curro #17942, who conducted the traffic crash Curro advised that V2 was stationary at the red light and was side swiped by V1 V1 continued westbound on Sample Road and came to a final rest at about the 200 block of east Sample Road When Deputy Curro made contact with the driver of V1, who was still sitting in the driver's seat, he observed the following signs of impairment, an odor of an alcoholic beverage emitting from her person, slurred speech, red/glassy eyes, flushed face and she was confused The driver was identified to be Tara Barker Both vehicles had to be towed due to the damage

I made contact with Barker, who was still sitting in the driver's seat I introduced myself and advised that the crash investigation was completed and I would be conducting a separate DUI investigation I asked Barker if she would be willing to conduct field sobriety exercises, she stated yes While speaking with Barker, I observed the following signs of impairment, an odor of an alcoholic beverage emitting from her person, red/glassy eyes, slurred speech and she swayed as she stood

During this exercise, the subject is instructed to place their left foot on the line and then place their right foot on the line, ahead of the left, touching heel-to-toe. They are then instructed to keep their arms down by their sides and to maintain this position until specifically instructed to begin. The subject is then told to take nine heel-to-toe steps along the line, turn around in a prescribed manner, and return nine heel-to-toe steps along the line. The turn is to be made by leaving the front foot on the line and turn around by making a series of small steps with the back foot. The steps and turn are demonstrated for the subject. The subject is told to keep their arms down by their sides, watch their feet at all times, and count their steps out loud throughout the exercise. The subject is then told that once they start walking, they are not to stop until the exercise is completed.

During this exercise, the subject is told to stand with their feet together and their arms down by their sides They are told to raise either foot that choose approximately six inches off the ground, keeping their legs straight and foot pointed out parallel to the ground They are told to keep their eyes on the elevated foot and count out loud in the following manner one thousand-one, one thousand-two, one thousand-three, and so on, until told to stop The exercise is conducted for thirty seconds

- Sways while balancing
- Puts foot down (before 30 seconds elapsed)
- **during the exercise, Barker fell to the ground

It was at this point in time, I made the determination there was enough probable cause to arrest Barker for DUI She was placed in handcuffs and asked if she would take the breath test, she agreed

Deputy Curro transported Barker to the Breath Alcohol Testing Facility (BAT) Once at the BAT, we made contact with breath technician Gray #10841 During Gray's 20 minute
