The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/03/2021, at approximately 1950 hours, the defendant and the victims were engaged in a verbal altercation that turned physical when the defendant ran at the victim and stuck Victim #1 in the face with a closed fist. The defendant was pushed down and repeatedly got back up and attempted to engage Victim #1. The defendant struck Victim #1 multiple times in the face causing permanent injury due to an inch-long laceration to their left cheek. Victim #2 attempted to assist Victim #1 when the defendant struck him in the jaw with a closed fist. Victim #2 suffered a swollen jaw and a bloody mouth causing permanent injury. Victim #2 then left the area and did not continue to engage the defendant. The defendant and Victim #1 continued to fight until Victim #3 attempted to assist Victim #1 also. The defendant then struck Victim #3 several times in the face with a closed fist. Victim #3 suffered a bloody nose, a bruised left eye, and chest pains. Post-Miranda, the defendant admitted to striking all three victims multiple times. All three victims identified the defendant as the person who committed the offense as they are neighbors. The defendant was positively identified via his FL DL.
