The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant was driving a black 2021 Toyota Corolla (FL Tag #QLGP99) northbound on Albany Av S, when she turned eastbound on Cleveland St W, and drove head-on towards me in my lane. This area of Cleveland St W is a 1-way road with westbound traffic only.

During the traffic stop for the wrong way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slow/deliberate movements, lethargic appearance, she said she had nothing to drink, but then changed her story and admitted to drinking "2 margaritas" while out to dinner earlier, and she emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking.

While at CBT, she was read Implied Consent and refused to take a breath test.
