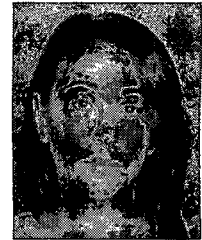

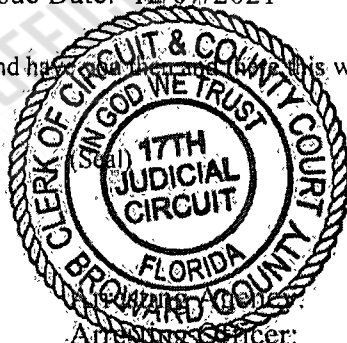

Before me this date personally appeared MASTRO, DAVID (9592) who being first duly sworn deposes and says that on 4 day of August, (year) 2021 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33024 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

his will and did intentionally cause great bodily harm to the victim. The defendant and codefendant kicked the victim in the face several times. The codefendant also struck the victim in the face with a closed fist causing the victim to immediately fall to the ground and lose consciousness. As a result of the defendant and codefendant's actions, the victim sustained two (2) brain bleeds and was put on a ventilator. The codefendant is a professional MMA fighter as well as a professional Ju Jit Su instructor. The codefendant also has a significant violent criminal history and is a convicted felon.

It should be noted that the victim was left completely defenseless due to his level of intoxication. The victim's blood-alcohol level was 0.344 when he was transported to the hospital.

The victim was transported to Memorial Regional Hospital in critical condition by Seminole Fire Rescue.

This is corroborated by video evidence along with sworn statements taken from all parties involved.

The defendant is being charged with Felony Battery and the codefendant is being charged with Aggravated Battery.
