The altercation then escalated to the point in which the def began to break items all over the residence and throwing them in the direction of the victim, almost striking other family members. This prompted the victim to attempt to restrain the def from in an effort to prevent hurting her son/witness who were in the immediate area and their mother (family room) While the victim bear-hugged the def, she requested her son to call Police for assistance.
