PROBABLE CAUSE

Before me this date personally appeared (Officer Kelleman CCN 875) who being first duly sworn deposes and says that on the (22) day of (September), (2017) at follows

The def (Capote) and her sister/victim were involved in a heated verbal altercation over personal matters. The altercation then escalated to the point in which the def began to break items all over the residence and throwing them in the direction of the victim, almost striking other family members. This prompted the victim to attempt to restrain the def from in an effort to prevent hurting her son/witness and their mother who were in the immediate area (family room). While the victim bear-hugged the def, she requested her son to call Police for assistance. During that same time, the def knowingly and intentionally bit the victim on her left arm causing a minor abrasion resembling bite marks and also pulled off some of the victim's hair.

It should be noted that while speaking to the def, she uttered that she bit the victim because the victim hates her and has been jealous of her since they were little kids, however, post Miranda, the def invoked her right to remain silent.

The statements were independently collaborated by the witnesses.

The victim and witness's refused to provide a sworn statement or have photographs taken.

The victim refused to prosecute however, due to the fact the victim and suspect are related by blood, the def was placed under arrest for domestic battery.

The def was subsequently transported to BSO main jail without incident.
