<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On the above listed date and time, at the above listed location, Deputy C Burgess (ABN 259132) made contact with the defendant after conducting a traffic stop on a black 2015 Nissan Rogue bearing FL tag PAFX61, after observing the vehicle weaving within its lane and almost strike a person walking on the side of the roadway. While Deputy Burgess was in contact with the defendant he observed several signs of impairment. Upon the affiant making contact with the defendant, I observed signs of impairment to include bloodshot watery glassy eyes, slurred speech, and the odor of an alcoholic beverage on her breath. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples after a proper 20-minute observation period (.179/.173 BrAC). The defendant was identified by her DAVID photograph.</p>
