The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a black Saturn SUV (FL PYTE93) that was stopped after it was observed driving in the wrong direction by heading westbound on W Platt St at S Albany Av. Traffic on W Platt runs eastbound at that location. Contact was made with the defendant whose eyes were red and glassy. She was slow to respond and there was a distinct odor of burnt marijuana inside the vehicle. She had body tremors and advised she just finished smoking marijuana. Se displayed additional indicators of impairment during SFSTs and was arrested for DUI. Two Ziploc-type baggies containing loose marijuana were found inside the vehicle during an inventory search. They were placed into evidence at the impound lot. The defendant was taken to CBT. She was read implied consent and refused to provide a urine sample. The defendant's identity was verified using her state of Florida driver's license.
