The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/10/2022, in the parking lot of Orangetheory Fitness which is located at 2052 Badlands Drive, Brandon, Florida Deputy J. Gay #261724 observed the defendant in a silver Dodge Ram 3500 bearing Florida tag: WEZR2 with an assigned VIN: 3C63RRJLXFG661580 in physical control of the vehicle sleeping, with the vehicle running. Deputy Gay responded to the area concerning a person down call for service. Upon Deputy Gay's contact with the defendant, he observed multiple indicators of impairment. While in direct contact with the defendant, I observed him to have bloodshot watery/glassy eyes, he had slurred speech, he was slightly unsteady on his feet and I smelled the strong odor of an alcoholic beverage emitting from his breath. The defendant refused to participate in the field sobriety exercises. Post Miranda, the defendant admitted to consuming several alcoholic beverages prior to being in physical control of his vehicle. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration he was placed under arrest for DUI. The defendant was transported to Central Breath Testing and he refused to provide two lawful breath samples. As a result, he was read Implied Consent and he continued to refuse by stating "Yes." I further identified the defendant via his DAVID photograph.
